You must supply referees who are willing to be contacted by telephone for additional information.

INTERVIEWS

If you are short listed, an interview will be required as part of the selection process. You will be required to attend an interview in person, at the Clayton campus, or by telephone conference. You will be informed in writing of the interview details.
